- Until further notice, meetings of the West Windsor Township Environmental Commission will be held using the Zoom meeting service.
- Members of the public (“Public”) can access the meeting using a computer or mobile device.
  - To access the meeting by computer or mobile device, use the link shown on the Environmental Commission Agenda posted on the Township Website – [www.westwindsortwp.gov](http://www.westwindsortwp.gov)
  - If using Zoom for the first time, you will be prompted to install the meeting app on your device. Once the app is installed, click on the link or paste it in your web browser to access the meeting. Click on the “join by computer audio” dialog box when prompted to do so.
  - The meeting host will admit you to the meeting once they are prompted to do so.
- The Public may be muted throughout the meeting.
- To make a comment or ask a question, please use the meeting “chat” or “raise hand” features, and follow the below guidelines:
  - Questions and comments for items *not* on the agenda will be addressed during the Public Comment portion of the meeting. Questions and comments related to specific agenda items will be addressed when the agenda item in question is reached.
