Updates from Health Officer:

Ms. Swanson provided the following updates:

1. Respiratory illness rates are improving for influenza, Covid 19 and RSV. She encourages caution in those over 65 years of age.
2. The Health Department held a Rabies clinic on April 24th where they provided 25 vaccinations. Ms. Swanson encouraged dog and cat owners to renew their annual pet license if they have not done so.
3. The Health Department is planning outreach events at the West Windsor Farmers Market. In the month of May, lead poisoning prevention sessions are planned at local day care centers. On May 17th for Summer Safety and May 21st for Healthy Outlooks Program. On June 24th a vision screening event is planned for Seniors.
4. The Environmental Health team is starting their busy season with over 400 temporary licenses, public pool inspections at 28 different facilities within the 3 towns.
5. Ms. Swanson encouraged the public to do some Spring cleanup around their homes and yards for mosquito control. Cleaning up brush and grass and low hanging branches and to visit the Department of Public Works homepage for rules regarding yard waste collection as well as reminders on household trash and goods. She also reminded residents fines can be issued for violations of noncompliance.

Council President Mandel offered a suggestion for grass clippings.

Councilmember Gawas asked for clarification on vaccine requirements and timelines and asked for more messaging to residents who were confused. Ms. Swanson reiterated there are multiple vaccine clinics throughout the year.

Council Vice President Geevers requested travel tips for staying healthy and asked about measles cases in the township. Ms. Swanson advised residents to look at the Health Department home

page and to stay up to date on vaccinations. She reported there are no measles cases in West Windsor but acknowledged some residents had been exposed do to international traveling.

Council President Mandel thanked the Health Officer for the first quarter report and asked if the cat license numbers had gone up. Ms. Swanson replied the numbers are slowly going up.
