RESOLUTION

WHEREAS, the Township of West Windsor is required to conduct remedial investigation activities at the former Wallace Road Bus Garage (Block 59, Lots 1 and 2) for groundwater contamination; and

WHEREAS, similar investigation activities are being conducted on property across Route 64 from the Garage property at JEM Cleaners (Block 5, Lot 20.01); and

WHEREAS, the Township recognizes the benefit of sharing access to groundwater monitoring wells and sampling test results in real time with the owner of Block 5, Lot 20.01 and their licensed professionals, and vice versa with the wells and sampling occurring on aforesaid Lot 20.01; and

WHEREAS, the Township wishes to enter into a Limited Access Agreement (“Access Agreement”) with the owner of Block 5, Lot 20.01 (Ellsworth Advisory Services, LLC) in order to permit the aforesaid sharing of access and information between the respective owners and their licensed professionals.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of West Windsor as follows:

- (1) The Mayor and Clerk are hereby authorized to execute, on behalf of the Township, an Access Agreement with the owner of Block 5, Lot 20.01 (Ellsworth Advisory Services, LLC).
- (2) The term of this Access Agreement shall commence as of the date this Access Agreement is executed by the Township and Ellsworth Advisory Services, LLC and shall terminate upon completion of the Work or December 31, 2026, whichever is earlier, unless sooner terminated pursuant to the terms of this Access Agreement.
- (2) An executed copy of the Access Agreement between the Township and Ellsworth Advisory Services, LLC and a copy of this Resolution shall be on file and available for public inspection in the office of the Township Clerk.







ENABLING RESOLUTION
FOR SUPPLEMENTAL FUNDING REQUEST

WHEREAS, the New Jersey Department of Environmental Protection, Green Acres Program ("State"), provides loans and/or grants to municipal and county governments and grants to nonprofit organizations for assistance in the acquisition and development of lands for outdoor recreation and conservation purposes; and

WHEREAS, the Township of West Windsor has previously obtained a Green Acres grant of \$10,225,000.00 from the State to fund the following project(s):

#1113-97-144 West Windsor Planning Incentive; and

WHEREAS, the Township of West Windsor desires to further the public interest by obtaining an additional Green Acres grant of \$ 1,637,000.00 to fund the project(s); and

WHEREAS, the State shall determine if the supplemental funding request is complete and in conformance with the scope and intent of the Green Acres Program, and notify the applicant of the amount of the funding award; and

WHEREAS, the applicant is willing to use the State's funds in accordance with its rules, regulations and applicable statutes, and is willing to enter into an Amendment of the Agreement with the State for the above-named project.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of West Windsor in the County of Mercer and State of New Jersey that:

1. Samuel J. Surtees, Land Use Manager and John V. Mauder, Chief Financial Officer are hereby authorized to:
 - (a) request such a grant,
 - (b) provide additional information and furnish such documents as may be required, and
 - (c) act as the authorized correspondent of the above-named applicant; and
2. The applicant agrees to provide the local government/nonprofit share if a match is required.
3. The applicant agrees to comply with all applicable federal, state, and local laws, rules, and regulations in its performance of the project.
4. This resolution shall take effect immediately.
